Location and Purpose and Need


This study examines I-95 from Exit 133 (US 17 N) to Exit 148 (at Russell Road), an extent that was previously studied in the 2011 I-95 High Occupancy Toll (HOT) Lanes Environmental Assessment (EA). The Fredericksburg Extension Study will involve the development of a Revised EA, which will document changes to the project since the release of the 2011 EA. The purpose and need for this study are carried forward from the 2011 I-95 HOT Lanes Project EA, and includes:

- Reducing daily congestion and accommodating travel demand more efficiently.
- · Providing greater reliability of travel times.
- Expanding travel choices by increasing the attractiveness and utility of ridesharing and transit usage, while also providing an option for single-occupant vehicles to bypass congested conditions.
